Here by Under Free and Compulsory Education Act-2009 and under Rules -2012 sub rules 18 and by agreeing below mentioned conditions we are temporarily declaring the renewal (Update) of school as unaided.

Conditions:

1. Under R T E Rules this Accreditation is temporary.
2. Under 2009 R T E Act Rule no 2012 applied schools are able to accept for grant.
3. School should abide to provide primary education up to 25% seats for the pupil who did not get opportunity to study, or below poverty level from grade 1st to grad 8th. If the school has preprimary education should follow the same rules without discrimination.
4. Under Section (3) Schools 12(2) schools are under comes under fee refund. Schools must have their separate bank accounts and must be verified by the Department.
5. Not to collect any donation from the parent by force in the time of admission or in the academic year. While taking renewal of accreditation (Grant) must take the approval for collecting fees by submitting fee receipts. Approved fee receipts should be displayed on school notice board.
6. By subject to the quality of education schools must not take any interview with parents or students.
7. Admission should be provided under the date limit mentioned by the Department.
8. Students Admission should not be refused by seeing their Date of Birth, Religion, Caste, Tribe, and Date of Birth.
9. Schools must follow rules mentioned below.
 - (i) Admitted students should not be left over from school or classes.
 - (ii) Not to hurt any students physically or mentally.
 - (iii) Not to force the Institute to promote the student till the child finish its education.
 - (iv) Study certificate should be given to the students after completion of study under section 38
 - (v) As mentioned in Act useful facilities should be provided to the special need children.
 - (vi) Under RTE rule appoint assigned educated staffs.
 - (vii) Salary assigned by state government and other allowances should be paid through bank and job safety should be provide,.
 - (viii) Teachers should obey Act24 (1) and RTE rule 16 and not to conduct any private tuitions and fees.
10. Schools should follow the textbooks according to the medium of teaching permitted.
11. Facilities should be provided according to the students ration mentioned in ACT 19 and maintain the quality.
12. Not to conduct any classes outside or inside the campus by breaking the rules.
13. Not to use school building or campus for any non- educational, commercial, or political program.
14. Not to use schools for the betterment of any society or group.
15. School expenses must be audited by chartered accountant and the copies must be forwarded to the office of Deputy Director through educational officer every year by end of June.
